With reference to the letter received vides Ref.1 & 2, it is informed that all staff members (Teaching, Non-Teaching & Ministerial) and students using a two-wheeler (both rider and Pillion rider) to the college must wearing a helmet and possessing a valid license are mandatory w.e.f from January 1, 2025. Those who fail to comply with these requirements will not be permitted to park their vehicles inside the campus. All staff and Students are requested to follow the directions of the Government without any deviation. The Circular referred above is available in the institute website.

20/19/2K Kindly refer to the Circulars cited above regarding compulsory wearing of helmet by all students/teachers/staff.

- 2. The UT of Puducherry has witnessed a manifold rise in the number of vehicles including two-wheelers in recent years. Increased vehicular density coupled with unsafe practices by road users have led to a significant rise in road accidents and fatalities, one among the highest in country per lac population. Non-wearing of helmet is one of the main reasons for such fatalities.
- Two-wheeler riders and pillion riders are vulnerable road users and their safety 3. is critical to achieve our objective to reduce fatalities in the UT. Keeping this in mind, Puducherry Traffic Police, under its 'Mission Zero Fatality' is going to launch compulsory enforcement of helmet use from January 01, 2025. General public, students and other road users are being sensitized by the Traffic Police about this mission through various road safety awareness campaigns.
- To emphasize wearing of helmet, It is requested that 4. students/teachers/staff under your control may kindly be sensitized regarding wearing of helmet while riding or pillion riding a two-wheeler for ensuring their personal safety as well as to avoid fine of Rs. 1000/- and suspension of driving license for 3 months u/s 194D of MV Act.

It is hereby informed that the Traffic Police of UT of Puducherry is going for compulsory enforcement of helmet use from January 1, 2025. As such it will be mandatory for the Students, Teaching staff and Non-teaching staff of the College / Institutions to wear helmet while riding / pillion riding two-wheelers for their personal safety as well as to avoid penal provisions.

2. Hence, the Principals/Heads of Institutions are hereby instructed to disseminate this information to all students and staff members, ensuring strict adherence to this policy.
